Hyperactivity

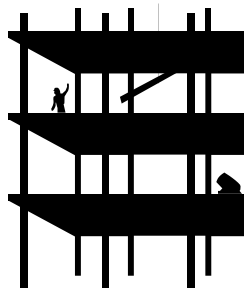
Defiance

How do I refer a child to the program?

Anyone can refer a child to the RBHA. Simply e-mail the Director at tillerj@rbha.org or call at 819-4065. You may also talk to your child's teacher or guidance counselor at the school to ask for more information.

Once a referral has been received, the RBHA intake staff will conduct an initial assessment with the child and guardian to determine if the child meets criteria for mental health services. Once the intake is complete, a child may begin participating in the program immediately.

Parent Support

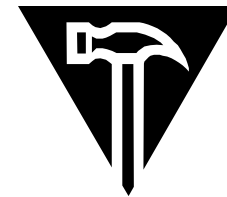
